HEALTH AND SALE REQUIREMENTS

Individual Females selling must be born on or after 1/1/2015 unless authorized by the sale management or the OAA. Embryos, Flushes, herd lots and pick of calf crops are permitted with permission of the sale management. Bulls born after 1/1/2020 must have breeding soundness exam and be authorized by the sale committee and the sale management. All cattle must meet health requirements to enter the state of Oregon before check in time. Please contact your state veterinarian for specific requirements as they all differ. Cattle entering will be reviewed by sale committee and the sale management and subject to be returned based on age, quality, pedigree and marketability

GENETIC TESTING

The Sale requires any consignment that are potential carriers for any genetic defect in their respective breed to be tested for which there is a commercial test available. Test results must be available and provided when the entries are submitted. The consigner is responsible for the cost of this testing. All other cattle must be free by pedigree for any known lethal genetic defect for which there is a commercial test available. If you are unsure of the status of your consignment, please contact your respective breed association.

DUES AND ENTRY FEE

Consigners DO NOT have to be a member of the Oregon Angus Association. Enter fee of \$100 per lot is due by March 30, 2020. Entries post -marked after 3/30/2020 will be required to pay \$150 per head entry fee. These fees are nonrefundable and will go towards the prorated sale costs. Animals MUST be registered at the time of entry. A registration number is required for entry. No pending registrations will be excepted. Registration on Pairs, if the calf was recently born the calf must be able to be registered.

SALE COST

The sale cost will be prorated per lot plus 5% sale management, 1% for Auctioneer and the Oregon Angus Association. The prorated sale cost include advertising, Liveauctions.tv, food, signage, ear tags, facility use and any additional costs, outside labor, equipment, products and services needed or used to conduct the sale. All no sales not meeting their floors will be charged at the established floor price given to sale management by breeder/consigner
