

**2020 Western States Angus Association Female Sale Entry Form**

**HEALTH and SALE REQUIREMENTS:**

Individual Females selling must be born on or after 1/1/15 unless authorized by WSAA or Sale Management (proven donor, etc.). Embryos, Flushes and Pick of Calf Crop or Herd lots are permitted with permission of sale management. All cattle must meet health requirements to enter the state of California before check in time. Please contact your state veterinarian (if applicable) for more specific requirements as they all differ. Cattle entered will be reviewed by Western States Angus Association Sale Committee and the Sale management and subject to be returned based on age, quality, pedigree and marketability.

**GENETIC TESTING:**

WSAA requires sale consignments that are potential carriers for any genetic defects listed by the American Angus Association to be tested for which there is a commercial test available, with the exception of OHP. Test results MUST be available and provided when entries are submitted. The consignor is responsible for the cost of this testing. All other cattle must be free by pedigree for any known lethal genetic defect for which there is a commercial test available. If you are unsure of the status of your consignments, please call the American Angus Association at 816-385-5500.

**DUES and ENTRY FEES:**

All consignors must be current members of the Western States Angus Association before consigning to the sale. If not currently a paid member, please add \$40 for membership dues to your entry fee. Entry fee of \$100 per lot is due by March 15, 2020. Entries post-marked after 3/15/20 will be required to pay \$150 per head entry fee. These fees are nonrefundable and will go towards the prorated sale costs. Animals MUST be registered at the time of entry. A registration number is required for entry. No pending registrations will be accepted.

**SALE COSTS:** The sale costs will be prorated per lot plus 5% for Sale management and WSAA and 1% (or minimum) for auctioneer. The prorated sale costs include advertising, Liveauctions.tv, food and refreshments, signage, ear tags, facility use and any additional outside labor, equipment, products and services needed or used to conduct the sale. All no sales not meeting their floors will be charged at the established floor price given to sale management by breeder/consignor.
